How to Leave a Gift in Your Will

If you wish to leave a gift to the Museum of Cambridge, we suggest using the following wording in your will:

"I give to the Museum of Cambridge [the residue] / [% of the residue] of my estate [or] [the sum of £x] free of tax for the general purposes of the Museum. I direct that the receipt of the Chair of Trustees or other proper officer for the time being of the Museum shall be a full and sufficient discharge to my Executors."

We encourage unrestricted gifts for 'general purposes', as this will allow the Museum to allocate funds where they are most needed.



There are four main ways of leaving a gift to the Museum:

- Pecuniary bequest: A fixed sum of money left to the Museum.
 This can be added to an existing will using a codicil. This form of gift is simple to arrange and can be index-linked to protect against inflation.
- Residuary bequest: All or a percentage of the remainder of your estate, after other legacies and expenses have been paid. This type of gift retains its value over time.
- Reversionary bequest: This leaves your assets to a named beneficiary for their lifetime, for example your spouse or other dependant, before being passed to the Museum.
- Specific or non-monetary bequest: A particular item that may support our collection or be sold to fund Museum activities.

Inheritance Tax Benefits

A charitable legacy does not count toward the taxable value of your estate. If you leave 10% or more of your net estate to charity, your inheritance tax rate is reduced from 40% to 36%.

As tax regulations can be complex, we strongly recommend speaking with a solicitor for advice.

Acknowledging your Gift

Making a will is of course an intensely personal matter, and we understand if you do not wish to inform the Museum in your lifetime. However, if you choose to let us know about your legacy, we would be incredibly grateful, as this helps us plan for the Museum's future and thank you in your lifetime.

All gifts over £1,000 will be acknowledged in our Annual Report unless you wish to remain anonymous.

Gift in Will Pledge Form

If you decide to leave a gift in your will, we would be hugely grateful if you could complete this form and return it to us.

This is a **non-binding pledge** and places no legal obligation on you, it is simply an expression of your current intentions and helps us with our long-term planning.
